NOTICE IS HEREBY GIVEN that **MONMOUTHSHIRE COUNTY COUNCIL** of County Hall, The Rhadyr, Usk, NP15 1GA ("the Council") pursuant to the powers conferred by Section 14(1)(a) of the Road Traffic Regulation Act 1984 do **HEREBY ORDER AND DIRECT** that for the purpose of the following regulations shall be observed:

- The Order shall come into operation on the 15th June 2020 and will continue to be in force for a
 period not exceeding 18 months or until the works which it is proposed to carry out have been
 completed, whichever is the earlier. It is anticipated that the works will be completed within 5
 weeks, between 15th June and 20th July 2020.
- 2. The order is necessary for works involved with the Monmouth Town Public Realm scheme carriageway to take place in a safe manner at the location. Reasonable access will be maintained for properties fronting the affected lengths of road during the period of the closure.
- 3. The effect of the order will be to temporarily close sections of Monnow Street, Agincourt Square, Agincourt Street and Priory Street, Monmouth, Monmouthshire
- 4. A signed diversionary route will be in place as follows:

Northbound: B4293 (Blestium Street), B4293 (Cinderhill Street), A40, A466 (Wyebridge Street), A466 (James Street), A466 (Monk Street), B4932 (Priory Street).

Southbound: B4293 (Priory Street), A466 (Dixton Road), A40, B4293 (Beech Road), B4293 (Portal Road), B4293 (Cinderhill Street), B4293 (Blestium Street).

- 5. This order may be cited as the Monnow Street, Agincourt Square, Agincourt Street and Priory Street, Monmouth, Monmouthshire Temporary Traffic Regulation Order 2020
- 6. By virtue of Section 16(1) of the Road Traffic Regulation Act 1984 a person who contravenes a restriction or prohibition imposed under Section 14 of the Act shall be guilty of an offence.

Monnow Street, Agincourt Square, Agincourt Street and Priory Street, Monmouth, Monmouthshire

Monnow Street: Closed from its junction with Agincourt Street/Agincourt Square to its junction with St John's Street.

Agincourt Square: Closed for its entirety.

Agincourt Street: Closed from its junction with Agincourt Square/Monnow Street for \sim 45m. Priory Street: Closed from Agincourt Square for \sim 85m.
