# 1. ABOUT MONMOUTH TOWN COUNCIL

#### **Background**

Monmouth Town Council is the tier of local government closest to the community and represents the views and interests of the people of Monmouth to other authorities including Monmouthshire County Council, the Police, the Welsh Government and others. In 2022-23, the number of elected Councillors for Monmouth was increased from 16 to 19 and these cover the 5 wards of Monmouth; Drybridge, Overmonnow, Osbaston, Wyesham and Town. A full list of Councillors can be found at Appendix 1 of this report.

The Councillors serve a population of 10,508 (2011 census).

The Mayor and Deputy Town Mayor are elected each year by the council at the annual meeting, usually heard in May.

#### **Election Year**

2022-23 saw the commencement of a new Council period following the local elections initially held on 5<sup>th</sup> May 2022. Monmouth Town Council had 5 people stand in May 2022 which, unfortunately, was not the required number of Councillors to allow the Council to function (inquorate) and so an additional election was required. During the period the Council was inquorate, the Town Clerk and Responsible Financial Officer had delegated authority to continue making the necessary payments and decisions for the benefit of the Council and the town.

A further election notice was approved by Monmouthshire County Council and on 26<sup>th</sup> May, an additional 9 Councillors were elected without contest. With these additions, the Council had the requisite number of Councillors to form and an Annual Meeting was called and held on 13<sup>th</sup> June 2022.

Following the uncontested election of 14 Councillors, a number of co-options took place due to vacancies and resignations, with the current 19 Councillors being in place since 27<sup>th</sup> March 2023.

#### **Committees**

All Councils conduct their business through meetings which are formal, agenda-led events with a clear purpose of making democratic decisions for the benefit of the town. As well as Full Council, which includes all elected members, the Council has 3 committees that meet on a regular basis. These are:

- > Finance and Policy, which meets 4 times a year.
- > People and Places, which meets once a month.
- Planning, which meets twice a month.

All meetings are open to the public and normally take place at the Shire Hall, Agincourt Square, Monmouth as well as being available via Zoom Conferencing. Planning, however, takes place at Bridges Community Centre and is also available on Zoom. Every agenda provides members of the public with an opportunity to address the committee or Council during a designated "Public Participation" item. This ensures there is opportunity for members of the community to be involved in the decision-making process. Meetings sometimes include invited guests to speak on particular agenda items, too.

Councillors have a duty to attend all meetings and must provide a reason for absence which is acceptable to Council if they are unable to attend. A record of attendance at meetings for all Councillors can be found at Appendix 2 of this report.

#### **Responsibilities**

Monmouth Town Council and Monmouthshire County Council are completely separate authorities with different responsibilities, however, both authorities work closely together on matters affecting Monmouth and its residents.

Monmouth Town Council has a number of assets in the town including the war memorial in St James Square, the public toilets at Agincourt Street, over 40 dog waste bins, Drybridge Play Park, the Town Field and a number of planters located both within the town and in residential areas. The Town Council also has the responsibility of the maintenance of the wooden planters in Monnow Street introduced as part of the COVID-19 measures installed by Monmouthshire County Council.

Monmouth Town Council also provides the Christmas trees, street decorations such as Christmas lights and bunting and the history banners displayed on Monnow Street.

In addition, Monmouth Town Council contributes to a number of services provided by Monmouthshire County Council such as CCTV, the cleaning and maintenance of Blestium Street public toilets, street cleaning and summer playschemes for local children to attend.

As part of our responsibilities, the Town Council hosts and/ or financially supports public events in the town such as Freedom Parades for the military, the Monmouth Carnival and the Christmas Lantern Parade to name just some.

The Town Council also financially supports a number of local organisations that provide benefit to the local community through grant funding or partnership agreements.


#### <u>Finance</u>

The Town Council is required to set an annual budget each year. The budget for 2023-24 is £588,030. From this, MTC determines how much to request from Monmouthshire County Council which collects the funds via Council Tax. This is known as a precept demand. Council agreed to fund £59,000 of the budget using money allocated for specific matters (Ear Marked Reserve) not currently required. Using these funds reduced the precept request and as a result, the precept for 2023-24 is £529,030 which represents an increase of £100,524 from 2022-23.

# 2. WELLBEING OF FUTURE GENERATIONS (WALES) ACT 2015

"The Well-being of Future Generations Act requires public bodies in Wales to think about the long-term impact of their decisions, to work better with people, communities and each other, and to prevent persistent problems such as poverty, health inequalities and climate change." (Future Generations Commissioner for Wales) Monmouth Town Council is one of the public bodies that is governed by this legislation. The legislation sets out 7 wellbeing goals that we should strive to achieve which are shown below.



It is imperative that, as a council, all decisions have consideration of the wellbeing goals for the benefit of the future generations of Monmouth but also the Wellbeing Plan that Monmouthshire County Council set for the whole County as a result of the 2015 Act.

The Wellbeing Plan for Monmouthshire has the following 4 objectives:

- 1. Provide children and young people with the best possible start in life.
- 2. Respond to the challenges associated with demographic change.
- 3. Protect and enhance the resilience of our natural environment whilst mitigating and adapting to the impact of climate change.
- 4. Develop opportunities for communities and businesses to be part of an economically thriving and well-connected county.

# 3. WHAT MONMOUTH TOWN COUNCIL HAS BEEN DOING IN 2022-23

This year has been an unusual year with it being the first time the Town Council started the year inquorate. In addition, the majority of the Councillors are new to the Council and so 2022-23 saw a great focus on training Councillors and building an understanding of Council matters. With that being said, the Council were still able to organise and host the Mayoral Civic Service, a Freedom of Monmouth Parade for the Royal Monmouthshire Engineers and a Remembrance Sunday parade and service.

Some of the key achievements for the Council are as follows:

#### a. <u>Partnerships</u>

This year saw the Town Council continue to support the partnership agreements established in previous years including Monmouth Carnival, The Savoy Cinema Kids Club and ACE Monmouth.

During 2022-23, the initial partnership agreement with Mind Monmouthshire came to an end. At the Full Council meeting in January 2023, the Council agreed to extend the partnership agreement for a further 3 years (2023-26) with the sum of £15,000 allocated to Mind Monmouthshire for each year of the partnership. Continuing the partnership ensures that the services of Mind Monmouthshire can remain in Monmouth and support the residents.

#### b. Community Events

Monmouth Town Council was able to support and/ or host the following events in 2022-23:

Queen's Jubilee Grants

In June 2022, Monmouth celebrated the Platinum Jubilee of HRH The Queen. Instead of a central event being organised, residents were encouraged to hold street parties



and celebrations within their local area or within their community group.



These events were facilitated by a Queen Jubilee Grant Scheme launched by the Town Council. Some of these events included a "Party on the Green", a "Big Lunch" in Wyesham Community Woods and a Royal Variety Show at 1 of the local primary schools. It also saw 2 trees

planted to commemorate the occasion; 1 in Kings Wood Gate and 1 in St Mary's Church grounds and a felled Cedar tree carved into a wooden sculpture at Bridges Community Centre. Over £11,000 was awarded through the scheme and it ensured the residents were able to enjoy the celebrations across all 5 wards of Monmouth. (photo credit C. Layne-Thomas and J. Duke)

Christmas Lantern Parade 2022

The new Councillors ensured that the Christmas Lanten Parade returned in 2022 with a number of the new Members taking lead parts of the organisation along with the community members that have always been a key part of the event. The theme this year was "Monmouth's History" which was supported brilliantly by the local residents with their lanterns. The working group arranged and held free workshops that allowed residents to make

#### Freedom of Monmouth Parade

The Royal Monmouthshire Royal Engineers have the Freedom of Monmouth and they asked the Town Council to host a Freedom Parade in September 2022.

Following the death of HRH the Queen, this parade was until postponed March 2023. The parade took place in front of a full crowd of Monmouth residents and guests including HRH The Duke of Gloucester and the Lord Lieutenant of Gwent. The Mayor, Cllr Alice Fletcher joined HRH The Duke of Gloucester on the

As part of the analysis of the applications received, the projects' ability to satisfy some or all of the goals is considered and is a strong determining factor.

#### d. ACE Monmouth Action Plan

One of the deliverables of the ACE Monmouth Partnership was for ACE Monmouth to prepare an action plan that could be adopted by the Town Council. The Action Plan was to provide the Council with a framework of projects, audits and processes that could be put in place to reduce the impact of the nature emergencies in Monmouth.

This Action Plan was presented to Full Council initially in September and later adopted, in principle, by the Town Council in October 2022. In December 2022, the Council set up an Action Plan Working Group that were tasked with investigating the proposals made by ACE Monmouth and looking to put the suggestions in action. This project continues with the support of ACE Monmouth members, Officers of MCC and led by the Town Councillors.

An example of the Action Plan is as follows:

#### e. Asset Acquisition

Cemetery

In 2022-23, the Council made progress with having the Monmouth Cemetery re-opened despite it being closed for over 15 years. The Council agreed to support the reopening by funding a new pathway and also committing to funding the ongoing maintenance of new graves. As the cemetery is managed by Monmouthshire County Council, the decision needs to be presented to Cabinet which is anticipated to happen in July 2023.

#### Allotments

In addition to the cemetery, progress was made with the Town Council taking over management of the Monmouth allotments situated near the Two Rivers Meadow. The Council has agreed to manage the allotments by working collaboratively with the already established Allotment Association. The site is currently managed by Monmouthshire County Council but it is hoped that by having the Town Council take control, the relationship between the Allotment Association, its members and the Council can be strengthened for the benefit of the town and its residents.

#### f. New Working Groups

- Community Engagement Strategy The Council recognise the significant importance of engaging with the residents of Monmouth to establish what it is that they want from the Council and their town. With this in mind, the Council set up a new working group to establish an engagement strategy to include a survey that will hopefully be circulated to all residences in Monmouth.
- Tourism Strategy

It is understood by the Town Council that the town relies heavily on tourists for the benefit of its economy. With this in mind, the Council hope to investigate ways of improving tourism in Monmouth and have set up a strategy group for this purpose. The group is considering possible coach parking ideas, marketing suggestions and establishing links to tourist businesses to ensure the tourism market remains in Monmouth.

#### Cost of Living Crisis

When the cost of living crisis was declared in 2022, the Council felt it was important to provide support to the residents who could be impacted by it. This resulted in the Cost of Living Crisis working group being established from which organisations and charities were invited to meet to discuss what could be offered in Monmouth. From these discussions, warm spaces were created for each day of the week in churches, community halls and the library. These warm spaces would offer food, drink and company for anyone who wished to use them. These spaces continued throughout the winter and into spring. The working group continues to offer support through the partnership with Monmouthshire County Council who are offering similar support systems.

#### g. Whole Office Review

Following the Whole Office Review undertaken in 2021-22 the following areas were identified for future improvement:

- 1. The introduction of an Investment Strategy, and more secure placement of MTC's funds.
- 2. The move over to MTC councillor email addresses.
- 3. The investigation of the BACS process to enable payments to be made on a monthly basis with one push of a button.

In 2022-23, the Council were able to achieve the transfer of a significant proportion of our General Reserves to the Churches, Charities and Local Authority Fund that provide specific investment for public and third sector organisations. The Council continues to hold accounts with Monmouthshire Building Society and Lloyds Bank but are reassured that the investment strategy has now been achieved.

In addition, all Councillors were given an MTC specific email address when elected to the Council in 2022. This increases the security of Council emails as well as ensuring that all emails are held on a central server.

The only outstanding consideration, is the investigation into BACS payments, but this will continue into next year as the current banking process remains effective and secure.

#### g. Biodiversity in Monmouth (S6 Environment Act 2016 (Wales))

Monmouth Town Council is committed to maintaining and enhancing biodiversity in Monmouth for the benefit of its residents and tourists to the area. The Town Council has ownership of only 2 open spaces in the town- the "Town Field" and a play park. The "Town Field" is an open field of trust along the banks of the River Wye and is predominantly used for dog walkers. The field is used for the annual fireworks display, rowing club regatta and the annual raft race organised by the Rotary. The Town Council also manages the planters and flower beds that are found in Monmouth high street and around the 5 wards of Monmouth. In total there are 66 planters and 9 raised beds.

As a result of the reduced amount of outside space that the Council has management of, we rely on working with other projects to enhance and encourage the biodiversity within the town. This report will highlight the number of initiatives and partnerships that the Town Council are a part with the hope that the biodiversity in the town remains.

#### What we have done

We work in partnership with Monmouthshire County Council to ensure a 'no spray' policy is practiced in our Town Field. We protect and encourage wildlife by being part of the **Nature Isn't Neat** project, which supports the re-wilding of green spaces and



planting pollinator-friendly plants to encourage bees and other pollinators.

In 2020, Monmouth was named the **first Bee Town in the UK** and also awarded the **Caru Gwenyn (Bee Friendly) award**. This was a

joint venture between the Town Council and community groups such as Bees for Development. The Council has continued its support of the Bee Town Status in 2022-23 through the continued planting of pollinator-friendly plants and use of peatfree compost in all the planters in and around the town. This has even been recognised by visitors to the town...

ACE Monmouth has now become a self-constituted group that will be supported by

the Town Council through a Partnership Agreement which will ensure that the efforts of the group continue to thrive. As part of the Partnership Agreement, members of the ACE group have prepared an **Action Plan** for Monmouth Town Council which has been adopted in principle. This plan gives areas for the council to focus on in their efforts to combat climate emergency and improve biodiversity. These areas include



procurement, energy, transport and nature. A number of mini projects and missions have been set from this action plan that will ensure continued biodiversity in the town.

Monmouth Town Council also supports the **Plastic Free Monmouth** scheme which



sets out to reduce the usage of single-use plastic that is washing up in our rivers and can be found increasingly in the countryside. By contributing funds to the drinking water fountains in the town we hope to reduce plastic waste even further and there are now 3 drinking fountains in Monmouth with a 4th due to be installed imminently. With our support and funding of Plastic Free Monmouth, the community-led steering group was able to obtain Surfers Against Sewage

accreditation for the town and have encouraged local businesses to reduce their use of single-use plastic and apply for Plastic Free Status.

The Council has also established a relationship with the **Friends of the Lower River Wye group** that are investigating the significant and damaging changes to the River Wye that has seen the demise of the biodiversity in the river. This group has been able to hold a "Wye July" event which highlighted the concerns regarding the River Wye.

We help to deliver a cleaner, greener Monmouth with the provision of **dog waste bins** and the '**Give Dog Fouling the Red Card**' campaign and also support our very active **litter group** (run in partnership with the local authority and a team of dedicated community volunteers).

Our **Active Travel working group** work diligently with the Local Authority to encourage the development of suitable routes for cyclists and walkers to reduce the use of vehicles and to consider such impacts when considering local planning applications. Provision for additional cycle parking in Monmouth was secured by the Active Travel group in 2022 with a covered shelter now sited near the Blesitum Street toilet block. The Town Council and the Active Travel group have also continued to be consultees for the development of an active travel route from Kingswood Gate and Williamsfield Lane, working with Sustrans and Monmouthshire County Council.

As a Town Council we also grant aid to local community groups for environmental projects such as the improvement of the Rockfield Community Garden. Consideration has also been given to improving the availability of local allotments and community gardens in Monmouth. It is thought that that will not only increase the biodiversity in the area but will also provide easier access to fresh, locally grown food.

# 4. Conclusion

Despite the unconventional start to the new Council term in 2022-23, it is clear that the new Councillors have taken to their roles with ambition, drive and determination. This has resulted in progress with ongoing projects, new projects commencing and relationships with the community being maintained.

Councillors were able to take the time in 2022-23 to establish a knowledge and understanding of the Council that has formed the foundation of a progressive and community-focused Council with a sense of unity and collaboration.

It is hopeful that 2023 will see an increase in community engagement, a focus on improving tourism in the town and the continued efforts of the 19 Councillors for the benefit of the residents with events being planned to highlight the bountiful history of Monmouth.
